#### (A) MODE OF MEETING

The Fiftieth Annual General Meeting ("**50**<sup>th</sup> **AGM**") of Muhibbah Engineering (M) Bhd ("**Muhibbah**" or "**the Company**") will be conducted on a fully virtual basis through live streaming and online remote participation and voting via Remote Participation and Voting ("**RPV**") facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("**Tricor**") in accordance with Section 327 of the Companies Act 2016 and Clause 57 of the Constitution of the Company ("**Virtual AGM**").

This is in line with Practice 13.3 of the Malaysian Code on Corporate Governance as a Virtual AGM facilitates electronic voting and remote shareholders' participation ultimately promoting greater shareholder participation. With the virtual meeting facilities, you may exercise your right as a member of the Company to participate (including the right to pose questions to the Board of Directors and/or Management of the Company) and vote at the Virtual AGM. Alternatively, you may also appoint the Chairman of the meeting as your proxy to attend and vote on your behalf at the Virtual AGM.

## (B) REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

- Shareholders who wish to participate in the 50<sup>th</sup> AGM may do so using the RPV facilities provided by Tricor. Shareholders are required to register via Tricor's TIIH Online website at <u>https://tiih.online</u> prior to the meeting. For more details, please refer to the Procedures for RPV set out below.
- 2. Shareholders who appoint proxies to participate via RPV in the 50<sup>th</sup> AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Saturday, 24 June 2023 at 2.00 p.m**.
- 3. Authorised representatives of corporate members must deposit their original certificate of appointment of authorised representative to Tricor no later than **Saturday**, **24 June 2023 at 2.00 p.m**. to participate via RPV in the 50<sup>th</sup> AGM.
- 4. Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor no later than **Saturday, 24 June 2023 at 2.00 p.m**. to participate via RPV in the 50<sup>th</sup> AGM.

## (E) POLL VOTING

The voting at the 50<sup>th</sup> AGM will be conducted by poll in accordance with Paragraph 8.29A(1) of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting and Cooper Professional Scrutineers Sdn Bhd as Scrutineers to verify the poll results.

Shareholders may proceed to vote on the resolutions from the commencement of the 50<sup>th</sup> AGM on **Monday**, **26 June 2023 at 2.00 p.m**. until the end of the voting session which will be announced by the Chairman of the meeting.

Upon completion of the voting session, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
