(A) MODE OF MEETING

The 48th AGM of Muhibbah Engineering (M) Bhd ("**Muhibbah**") will be conducted virtually through live streaming and online remote voting via Remote Participation and Voting facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("**Tricor**"). Please note that members/proxies **ARE NOT ALLOWED** to be physically present at the Broadcast Venue.

(B) REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

- 1. Shareholders who wish to participate in the 48th AGM may do so using the RPV facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("**Tricor**"). Shareholders are required to register via Tricor's TIIH Online website at https://tiih.online prior to the meeting. For more details, please refer to the Procedures for RPV set out below.
- 2. Shareholders who appoint proxies to participate via RPV in the 48th AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Sunday, 27 June 2021 at 1.00 p.m.**

(c) Online Remote Voting	Select the corporate event: "(REMOTE VOTING) MUHIBBAH 48 TH AGM".
	Read and agree to the Terms & Conditions and confirm the Declaration.
	Voting session commences from 1.00 p.m. on Tuesday, 29 June 2021 until a time when the Chairman announces the completion of the voting session of the 48 th AGM.
	Select the CDS account that represents your shareholdings.
	Indicate your votes for the resolutions that are tabled for voting.
	Confirm and submit your votes.
(d) End of remote participation	Upon the announcement by the Chairman on the closure of the 48 th AGM, the live streaming will end.

(E) POLL VOTING

The voting at the 48th AGM will be conducted by poll in accordance with Paragraph 8.29A(1) of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting and Cooper Professional Scrutineers Sdn Bhd as Scrutineers to verify the poll results.

Shareholders may proceed to vote on the resolutions from the commencement of the 48th AGM on Tuesday, 29 June 2021, at 1.00 p.m. until the end of the voting session which will be announced by the Chairman of the meeting.

Upon completion of the voting session, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
